### FULL TERMS & CONDITIONS

DeWalt Generators, P2, Sydney Promotional period is 11<sup>th</sup> August – 25<sup>th</sup> August 2022

DeWalt Generators, P3, Brisbane Promotional period is 18<sup>th</sup> August – 1<sup>st</sup> September 2022

DeWalt Generators, P4, Adelaide Promotional period is 29<sup>th</sup> August - 12<sup>th</sup> September 2022

DeWalt Generators, P5, Perth Promotional period is 6<sup>th</sup> October - 20<sup>th</sup> October 2022

  3. The P2 Promotion commences at 12:00 pm AEDST on 11<sup>th</sup> August 2022 and closes at 11.59 pm AEDST on 25<sup>th</sup> August 2022 (“Promotion Period”). Redemption claims for the P2 promotion must be made online before 11.59pm 25<sup>th</sup> August 2022.
  4. The P3 Promotion commences at 12:00 pm AEDST on 18<sup>th</sup> August 2022 and closes at 11.59 pm AEDST on 1<sup>st</sup> September 2022 (“Promotion Period”). Redemption claims for the P3 promotion must be made online before 11.59pm 1<sup>st</sup> September 2022.
  5. The P4 Promotion commences at 12:00 pm AEDST on 29<sup>th</sup> August 2022 and closes at 11.59 pm AEDST on 12<sup>th</sup> September 2022 (“Promotion Period”). Redemption claims for the P4 promotion must be made online before 11.59pm 12<sup>th</sup> September 2022.
  6. The P5 Promotion commences at 12:00 pm AEDST on 6<sup>th</sup> October 2022 and closes at 11.59 pm AEDST on 20<sup>th</sup> October 2022 (“Promotion Period”). Redemption claims for the P5 promotion must be made online before 11.59pm 20<sup>th</sup> October 2022.
